**PURPOSE AND METHODOLOGY**

The purpose of this review was to compare the program's documentation and practices for compliance with the Ohio Department of Alcohol and Drug Addiction Services' Standards for Alcohol and Drug Addiction Treatment Programs. The applicable Standards for this program are: OAC 3793:2-1-01 through 3793:2-1-07, and Rules 3793:2-1-08, 3793:2-1-09, 3793:2-1-11, 3793:2-1-14, 3793:2-1-16 and 3793:2-1-17 of the Ohio Administrative Code. The program has applied for outpatient treatment program certification (OAC 3793:2-2-01).

Services provided as identified by the agency are:

1. Assessment (3793:2-1-08)
2. Crisis Intervention (3793:2-1-09)

3. Individual and Group Counseling (3793:2-1-11)
4. Drug Screening Urinalysis (3793:2-1-14)
5. Case Management (3793:2-1-16)
6. Intensive Outpatient (3793:2-1-17)

Administrative, personnel and quality assurance policies and/or procedures were reviewed for compliance with the Standards. A random selection of client charts and personnel files were reviewed as well to determine completeness, content and to assure appropriately trained professionals are providing the approved services.

The primary representative who participated in the exit interview was: Penny Walker, M.S., CCDCIII-E.

The following deficiencies were identified:

1. The program does not have an affiliation agreement with a hospital/medical center for emergency medical services, as required by OAC 3793:2-1-05 (E).
2. The program does not have written dietary policies and/or procedures for preparing and serving special diets, as required by OAC 3793:2-1-05 (G)(1b).
3. The program does not have written policies and/or procedures for the procurement of food, as required by OAC 3793:2-1-05 (G)(1c).
4. All Crisis Intervention Service providers are not current in the following training:  
  
Cardio-Pulmonary Resuscitation (CPR), as required by OAC 3793:2-1-09 (G)(1)  
  
First Aid, as required by OAC 3793:2-1-09 (G)(2)  
  
De-escalation, as required by OAC 3793:2-1-09 (G)(3)




