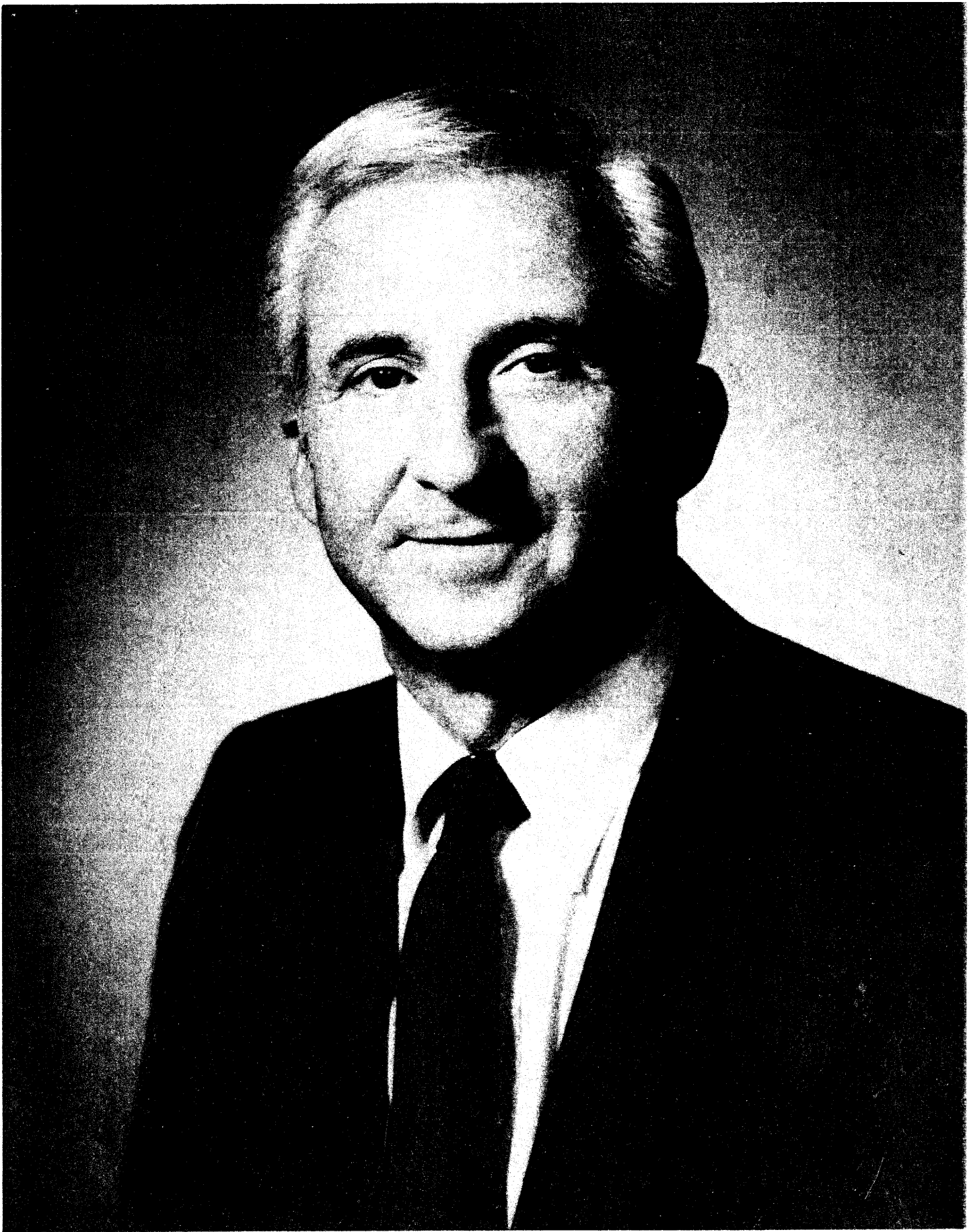

## MEL SEMBLER BIOGRAPHY

Mel Sembler has always been a man of strong convictions who demands nothing less than the best. But it is a way of life not just reserved for his business--he also wants it for his community. Sembler is always ready to pour time and energy back into the community to make it a better place.

A dedicated family man, Sembler and his wife, Betty, raised three sons who now serve as officers of The Sembler Company, a dynamic organization which has developed more than 3 million square feet of retail space. Based in St. Petersburg, the company has developed seventeen community shopping centers in Central Florida, plus two in Tennessee.

Concerned about youths in the community who were turning to drugs, he rolled up his sleeves and went to work, founding STRAIGHT, INC., a drug rehabilitation program presently serving more than 1,000 pre-teens and teenagers in nine cities. The program has graduated more than 5,000 children since inception. He still serves as Chairman of the Board of The Straight Foundation.

Sembler is now prepared to focus his energy on the International Council of Shopping Centers. Beginning in May, 1986, he will serve as president of this 18,000 member worldwide organization for the next twelve months. It is the preeminent organization for the shopping center industry.

His energy, drive, and enthusiasm for the shopping center industry should make his year as president an exciting one indeed.



## THE SEMBLER COMPANY PROFILE

After nine years in fashion specialty retailing, Mel Sembler decided in 1962 to begin a career in the shopping center industry. His first center was the 85,000-square foot Green Village Shopping Center in Dyersburg, Tennessee.

Success at Green Village soon spawned the next project, Jackson Plaza in Jackson, Tennessee. This 225,000-square foot project was also a success and Sembler's mark on the shopping center industry was made.

In 1968, Sembler moved his family and business to St. Petersburg, Florida. He quickly found that Florida was a dynamic market ready for his style of innovative design and quality construction.

His first Florida project, Jefferson Plaza in Fort Pierce, had 170,000 square feet of retail space and a long waiting list of tenants throughout the construction process.

Known for innovation, The Sembler Company received a Design Excellence award from the International Council of Shopping Centers in 1982 in the "Innovation, Design and Construction" category for Mill Creek Mall in Kissimmee."

The unique design allowed for doubling the square footage in the highest traffic location of the center--between the anchor tenants. This was accomplished by using a conventional strip center format with one exception: two small rows of smaller tenants face each other in enclosed space between the anchor stores. The advantages include lower construction costs, enclosed shopping which creates more customer browsing, and added exposure for small retailers of shop locations up front. Hurried shoppers have quick access to the major anchor tenants yet are adjacent to the smaller tenants.

This design made Mill Creek very energy efficient because air conditioning was not required. Extensive use of natural woods on store fronts and sign control also enhance the appearance.

The Sembler Company also is known for its unique renovation of shopping centers. The company renovated and expanded Dolphin Village on St. Petersburg Beach in 1984. It transformed a seventeen-year old shopping center into an art deco landmark that received recognition by the National Mall Monitor as winner in the category of "Open Renovation" in The Centers of Excellence Competition.

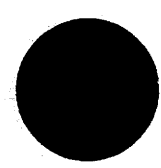
