Sarah, I thought the best way to give you information on the First Ladies Conference was to send you a booklet on the program itself along with the statements of the First Ladies who attended the conference.

Basically the conference, as was our first in April of this year, was a mother to mother event. Mrs. Reagan felt that the conferences should address the problem of drug abuse as a social phenomena rather than a political one. Both of the conferences were resounding successes and many of the first ladies returned to their countries to begin programs of their own similar to what is being done in the U.S.

The First Ladies who attended the U.N. function spent the morning listening to experts discuss prevention, treatment, and issues revolving around drug abuse. They also heard from three young people, one from Germany, one from New York, and one from London discuss their involvement and experiences with drug abuse.

Following the morning session all of the First Ladies participated in a working luncheon to share ideas and opinions about the topic of substance abuse. There were 31 First Ladies in attendance including Mrs. Reagan and Mrs. Peres de Cuellar, wife of the Secretary General of the U.N.

The first conference was held for two days in April in which seventeen first ladies attended. The program was similar in nature although the conference was held at the White House on one day and then in Atlanta, Georgia the next where the ladies participated in a conference on drug abuse in that city.

Dear Mr. Barun:

We appreciate your interest in Straight and your questions regarding the lawsuit filed by Fred Collins against Straight. The surface issues in the Collins suit were fairly straight forward:

- * Fred Collins was a 19 year old, male adult and a resident of Virginia who, for a period of about six months, was a client in our St. Petersburg, Florida facility. He, along with his brother, George, enrolled in Straight at the insistence of his parents.
- * When the Washington Straight program opened in 1982, Fred and his brother, George, were transferred to Washington along with the other young people from that area. They lived in their own home.
- * Fred ran away from his own home, contacted an attorney, and filed a lawsuit making three allegations: that Straight had physically abused him; that Straight had psychologically abused him; and that Straight had illegally detained him.
- * A trial was held in Federal Court in Virginia. The jury found that: Straight had not physically abused Fred Collins; Straight had not psychologically abused Fred Collins; Straight had illegally detained him (this, in spite of the fact that his family testified on our behalf).

The obvious question then arises, why did this happen?

In analyzing the court's findings, we draw the following conclusions: since Straight is a treatment program primarily for minors, we had not adequately developed a system to insure the due process rights of adults when we decided to admit adults; and documentation (an all important issue in court) was inadequate in the illegal detention charge.

We corrected both of these deficiencies immediately and consider the Collins case, although painful and embarrassing, a lesson which we, like hospitals, schools and mental health facilities before us, had to learn the hard way. We have learned it.

I sincerely hope this is helpful.
