

HEALING BROWNE SITS OUT FIRST EVENT

This was the week Olin Browne was going to be standing alongside Fred Couples and Tiger Woods on the range. Maybe grab a little lunch with Mark O'Meara and David Duval, then head out for a practice round with, say, Davis Love III and Phil Mickelson.

And have a shot at winning \$475,000 for playing four rounds of golf in Hawaii.

Those were just some of the perks Browne earned by winning last year's Greater Hartford Open - his first victory in five years on the PGA Tour - and making the winners-only field for the Mercedes Championships, which kicks off the 1999 PGA Tour season today (7:30 p.m., ESPN).

Instead, Browne will spend the weekend at his Jupiter home, resting his left arm. At least he'll get the last-place prize of \$38,700 - though it won't count as official money.

``It's not about cashing in," Browne said. ``This was going to be my first exposure to something like this. I'll definitely watch because I'm a big fan, but I might lock myself in a room with a bottle of whiskey."

Browne isn't the only area player who'll miss the Mercedes. Jupiter Island's Nick Price will skip the tournament because of scheduling problems.

Last year marked a breakthrough for Browne, 39. He finished 47th on the money list with \$590,240, but his season ended after the PGA Championship because of recurring pain in his left elbow. In October he underwent surgery to remove scar tissue.

He likely will be sidelined until the Doral-Ryder Open the first week of March, but hopes to start hitting balls next month.

"It's hard to complain about having set myself up for a couple of years," he said. "This is just a minor bump for me. It's not career-threatening, and I feel like I finally have a good diagnosis. I know I'll be back."

Just not soon enough to enjoy this week's spoils.

Murphy Challenge Friday: The ninth annual Bob Murphy Challenge will tee off at 8 a.m. Friday at Emerald Dunes in West Palm Beach. Murphy will be joined by other locally based Tour players, including Bruce Fleisher of Palm Beach Gardens, Michelle McGann of Singer Island, Larry Laoretti of Palm City, Ed Dougherty of Port St. Lucie and Tom Shaw of Plantation.

The pro-am scramble raises money for Hook a Kid on Golf, a program of the West Palm Beach-based National Alliance for Youth Sports. Hook a Kid on Golf holds free weeklong clinics and conducts league play in a Ryder Cup-style format.

Accolades to the Sun-Sentinel for the editorial titled "Help budget writers do their jobs." If even 5 percent of the readers heed your advice, what a better place South Florida could be.

With the Republicans wanting a budget cut, more and more social programs that are in place to help right here in South Florida will be cut. Many programs have been cut already.

A well-respected Broward circuit judge advised a courtroom a few weeks ago that funding for drug rehabilitation in Broward County has been cut. The room full of parole-violation addicts, as well as other addicts awaiting a variety of hearings, heard that it's jail -- nothing else.

The American Medical Association declared drug and alcohol addictions as diseases many years ago. Is jail the way we should treat the body that is riddled by disease?

Seven-day detox centers and 30-day rehabs will not cure the diseased body that has been ingesting drugs for years.

What is the answer?

What about alternative, long-term treatments?

In Miami-Dade County, a now retired judge ordered acupuncture and hypnosis.

There is Growing Together in Palm Beach County (561-585-0892) for young adults ages 12 to 21. The treatment ranges from one year to 18 months and the success rate is 65 to 75 percent. Then there is Narconon, (800-468-6933) a long-term rehab that uses vitamins, minerals, healthy foods, exercise, sauna and developmental education. Success rate: 70 percent.

Drug and alcohol abuse has affected the affluent, athletes, celebrities, family, friends and co-workers. Intolerable anguish is felt by those who see the stranglehold that addiction has, luring and devouring loved ones in a pit of despair. How many have lost a loved one to an overdose of drugs?

The suicide rate is pushed upward by people's overuse of drugs and alcohol as well.

And what of their quality of life? Would death by injection be preferable? Call Dr. Kevorkian to end their lives of misery. Barbaric? How different is it from throwing the diseased human body, riddled by addictions, into jail?

There are pills to make you stop smoking, eat less, or feel less anxious or nervous. Shouldn't someone do research on a pill to cure addictions?

Health insurance probably would not cover this pill anyway. For those that have insurance, it usually only covers 30 days in a rehab. A 30-day miraculous recovery? Not hardly. Many insurance policies cover only a once-in-a-lifetime treatment in a rehab.

Ever call for information concerning the treatment plan of rehab centers? Many of them will not even talk to you before getting all of your insurance information. So the families who have money, or the means to borrow the money, can look into the longer term and alternative ways of treatment for the addicted.

Have empathy and take a stand to help the addicted. Here in South Florida we have so many very intellectual and affluent citizens. Many already give to their favorite charity or cause.

I ask that in your giving you do not look down on the drug- or alcohol-addicted. They are overwhelmed by despair. They would much rather be happy, healthy individuals, with jobs that they could keep and dreams that could become reality.

Those who cry out for help need our understanding and assistance.

Contact your local county commissioners, then the state Legislature, finally representatives and senators in Washington for help in treating the diseases of drugs and alcohol.

Tests can bring distrust, parents warned

Most agree testing on a whim can cause a major rift.

The screening kit contains equipment that will test urine samples for a number of drugs including cocaine, heroin, marijuana and amphetamines. The samples are mailed to a laboratory, which will send back the results to parents in a couple of days.

STUART - A national anti-drug group is trying to make it easier than ever for parents worried that their children are using drugs to have them tested at home, without spending time or money by going to a hospital or clinic.

But before parents start reaching for kits to screen their teens for drugs, they need to talk to their children about the issue or face a wall of distrust, mental health experts said.

Martin County's Drug Abuse Awareness program on Wed-nesday received 500 of the kits from Drug Free America, a non-profit group based in Palm Beach County. The kits were among more than 8,000 that will be made available to community groups, law enforcement agencies and parents in Martin, Palm Beach, Broward and Orange counties.

The kits are free, the results confidential, and testing is relatively convenient since it can be done at home.

But the question remains: Should parents randomly test their children for drug use?

Some say yes, others no, but most agree that testing on a whim or on a slight suspicion can cause a major rift in the parent-child relationship.

"The issue that applies here is, perhaps there will be a breakdown in trust in a youngster who has been doing very well and there was not a reason in the first place to test," said Dominic Zaccheo, a Stuart clinical psychologist.

Drug Free America was founded by Douglas Smith, who as an emergency room doctor at Good Samaritan Medical Center says he sees firsthand the destruction done by drugs to children. Its honorary chairmen are Alexander Haig, former secretary of state, and U.S. Rep. Mark Foley, who represents much of the Treasure Coast.

"You reach a point in this madness where you have to do something. You see parents who come in with their children and say they want a drug screen done on their child," Smith said.

Smith stressed that use of the kit is optional to parents, and children who say they do not want to undergo a test should not be forced to.

But he said testing can head off potential problems and allow parents to work out problems with their children before drugs become a serious problem.

The American Civil Liberties Union, which opposes drug testing in the workplace, has taken no legal stand on the issue of parents, said Rosemarie Richard, president of the Treasure Coast chapter of the ACLU. Still, she said, members have reservations about the practice.

"The short answer is that the ACLU has looked at it and determined that the policy does not infringe on constitutional rights," she said. "Basically a parent has tremendous leeway with their child."

Mickey Bowman, CEO of Growing Together, an adolescent treatment center in Palm Beach County, said she "quasi supports" the kit program, but with conditions.

The big one being the need for communication between parent and child, she said. Before parents even get a kit they should tell their children that there is a chance of random screening.

"If the child comes up clean, that's good," she said. "If not, the parents need to say, let's sit down and talk."

Anita Petzold, coordinator of the county's drug abuse program, said the kits are a free alternative to concerned parents who do not have

the money to pay for drug screening, which can run \$30 and more.

"I get calls from parents all the time who want drug testing kits but can't afford them," she said.

Petzold said the test results are between the parent and child and her agency; law enforcement or anyone else is not involved.

"This is not to be used to punish a child. It's to help treat an addiction," she said.

The screening kit contains equipment that will test urine samples for a number of drugs including cocaine, heroin, marijuana and amphetamines. The samples are mailed to a laboratory, which will send back the results to parents in a couple of days.

Smith said if the test turns out positive, it is up to the parents to make the next move.

Zaccheo said parents need to determine whether their child is chemically dependent or experimenting, and a drug test might not be the best way to do it.

He suggests that parents who think they have a child with a problem should get in touch with a professional who can help determine how serious the situation is and what can be done about it.

"The parent does not have to get into an accusatory and combatant relationship," he said.
