Seven local charities were presented checks totaling more than \$2,100 from Hoffman's Chocolate Shoppes and Gardens in Lake Worth for the third annual Dream Trees Competition.

The winner was Center for Children in Crisis. The center received a check for \$635.67 and an additional \$50 from the Hoffman family

Volunteers and staff from the charities competed during the annual Hoffman's Holiday Wonderland to raise money for their organizations by decorating a five-foot tree in a theme expressing their dreams. Visitors to the wonderland acted as judges by selecting their favorite tree and making a donation to the charity of their choice. The charity receiving the most donations was the winner.

Participating charities included: The Alzheimer's Association; Children's Home Society; Kids Helping Kids; Deaf Service Center of Palm Beach County; Gratitude House; and Growing Together. The Center for Crisis is a private, nonprofit organization serving Palm Beach, Martin, St. Lucie, Okeechobee, and Indian River counties. Its mission is to identify and to protect abused and neglected children, to provide comprehensive treatment for incest victims and their families.

Rep. Suzanne Jacobs, D-Delray Beach, presented checks totaling more than \$30,000 from the department of the state to five Palm Beach County cultural agencies. The grant money is part of \$3.7 million the county's libraries, cultural institutions and historic preservation projects received from the state in 1995.

The recipients are: Palm Beach County Library System - \$8,522.50; Ballet Florida - \$7,278; Lake Worth Public Library - \$6,116.50; Palm Beach Pops - \$5,600.50; Boynton Beach Historic District - \$2,500.

As a father, it breaks one's heart to see these families torn apart by drugs, but it's rewarding to know there is a program trying to mend them back together in addition to attempting to heal these young people for the life's journey ahead.

I just returned from spending four days, along with 20 other men, inside Okeechobee Correctional Institution. This ministry, Kairos, goes into prisons in an attempt to heal and give a new direction through Christian love to 36 men. Most inmates are there because they committed drug-related crimes. We can only hope that Growing Together's program can rescue many young people from incarceration.

By the way, we also sang the "hokey" campfire song "It only takes a spark to get a fire going" ... except that to those inmates, it wasn't hokey.
