GATED ENCLAVES RICH SOURCES OF CHARITY - LOST TREE VILLAGE MILLIONAIRES HAVE OWN FOUNDATION

Lost Tree Village, like plenty of other gated communities in South Florida, offers its residents a country club, beach house, pro shops, even a chapel.

But what sets it apart is its optional, residential tax write-off - an elite, IRS-approved philanthropy, which allows donors to take a charitable tax deduction for up to 50 percent of their adjusted gross income in a single year.

Of course, the money taken up each year from residents such as golfer Jack Nicklaus or General Electric Co. CEO Jack Welch also makes the charity all the greater an amenity for the area outside this exclusive, oceanside golf community nestled between North Palm Beach and Juno Beach.

With \$2.9 million in assets and \$712,500 given to 53 nonprofits in Palm Beach and Martin counties in 1997, the 16-year-old Lost Tree Village Charitable Foundation is among the best organized and best known among similar groups that have quietly been springing up in wealthy enclaves all over Palm Beach County.

"It has developed into almost like a United Way. . . . I told them, 'I wish we could clone you all over Florida,'" said Dot Ridings, president of the Council on Foundations in Washington.

Not everyone feels that way. The creation of each such neighborhood charity means another contingent of South Florida's winter residents and wealthy retirees bypasses the local community foundations, United Ways and Jewish Federations that have historically been the dominant means for taking up collections and picking the charities that get the money.

By comparison, the United Way of Palm Beach County raised \$9.2 million in 1997-98, up from \$8.1 million in 1996-97, and the United Way of Martin County raised \$1.7 million in 1997-98, up from \$1.5 million the previous year.

Gated approach: Isolationist?

Though many admire the Lost Tree Village concept for its level of organization and commitment, some of the established groups view the further spread of the gated-community approach with mixed feelings.

"I fear that it may Balkanize those gated communities and keep them from getting to know the larger community and operating in a vacuum," said Shannon Sadler, president of the \$80 million Community Foundation for Palm Beach and Martin Counties. "I just don't want them to stay behind those gates forever."

But Palm Beach County United Way Executive Director Scott Badesch said, "Anything that brings in money to human services is something that ought to be applauded."

Last year, an all-time high of 151 families each gave at least \$2,500 to the Lost Tree Village Foundation. Overall, residents pumped a record \$724,000 into the charity.

Because the Lost Tree foundation is classified as a public charity, donors not only can write off 50 percent of their gross annual income if they give that much, but they can deduct the full market value of a gift of publicly traded stock.

Those are better breaks than afforded by a private foundation, whose donors can write off only 30 percent of their gross adjusted income and, when it comes to stock, can write off only what they originally paid for the stock. A foundation also must pay a 2 percent tax on its investment income, but a charity doesn't. Lost Tree group changed its legal status from private foundation to public charity in 1992. While both are Internal Revenue Code classifications, becoming a charity is tougher because it must meet the IRS's test for broad public support while a foundation can be an endowment created by one person.

Giving is not uncommon

Most Lost Tree donors are hardly philanthropic neophytes: Some have their own foundations and substantial reputations as philanthropists.

"It's a very thorough operation. I'm impressed with it," said 18-year Lost Tree Village resident Leslie Quick Jr., CEO of the Quick & Reilly brokerage firm in Palm Beach. "You've got a lot of sophisticated people, a lot of people high up in industry and charity work."

Quick estimated he has given the Lost Tree group about \$100,000 in eight years. He has his own foundation, the Leslie C. Quick Jr. and Regina A. Quick Charitable Trust Foundation. He said his foundation, formed in 1988 and with \$6.6 million in assets in 1997, sometimes gives to the same groups picked by Lost Tree Village.

Lost Tree's gifts in 1997 ranged from \$1,000 to the Salisbury-Sexton/Communities in Schools Memorial Scholarship, a high-school dropout prevention program, to \$50,000 for the Glades Community Development Corp., to pay for after-school and family programs.

The grant recipients are picked by the Lost Tree's 50-person visiting committee, which sends teams of three to five inspectors to local charities.

Charities date to '40s

While Lost Tree's charity is perhaps the most emulated, it was not the first neighborhood foundation in the area.

One of the earliest localized money-raising efforts was the Hobe Sound Community Chest, formed in 1949. The community chest raised \$290,000 last year from residents of Hobe Sound and Jupiter Island and gave out \$226,000 to 32 organizations. The gifts ranged in size from \$50 for the Hobe Sound Nature Center to \$77,000 for the Hobe Sound Child Care Center. Along with gifts to the Hobe Sound Volunteer Fire Department, Jupiter Island Garden Club and United Way of Martin County, the group also gave \$100 to the National Hemlock Society and \$5,000 to the Yale School of Medicine. The Eastpointe Country Club Charity Fund in Palm Beach Gardens was formed in 1980. It raises money during one week of golf tournaments and luncheons and distributes it to charities in Palm Beach County. It raised \$64,000 last year and \$675,000 since its formation.

The Frenchman's Creek Charities Foundation, in Palm Beach Gardens, was created in 1993 and holds one "Charity Day" event each year, usually golf, tennis and card tournaments. In March, its 595 country club residents and some outside donors raised \$76,000 and distributed it to 38 charities.

The Abacoa Partnership for Community, in Jupiter, was created in December and plans to make grants in Abacoa and surrounding northern Palm Beach County. Unlike other groups, it will raise money from businesses and commercial property owners. It has received a \$200,000 start-up grant from the John D. and Catherine T. MacArthur Foundation.

New groups take tips from old

The most recently formed is the Piper's Landing Community Fund. The Palm City group, just west of Stuart, received public charity status from the IRS on June 19. Board member Richard Enright said the board will seek guidance from the Lost Tree and Hobe Sound groups.

Enright said most residents of Piper's Landing are snowbirds with a charitable bent but little knowledge of area nonprofits. They need help sorting through solicitations but also want to make their philanthropy more engaging than just writing checks to strangers.

"The board of directors will be able to chat about the activities when they're playing golf," he said. "What you want to have is the personal connection."

Money raising by the Lost Tree Village Charitable Foundation also is deliberately low-key, with members often promoting their causes on the golf course and at bridge parties, said foundation President James Gillin. Each year, the group also mails Lost Tree's 500 households a money-raising letter and holds a party for benefactors who gave at least \$2,500 in the past year or \$25,000 total.

Last year's soiree honored the largesse of such residents as Nicklaus; Welch, of General Electric; Lawrence Bossidy, the CEO of aerospace engineering giant Allied Signal; Bradford Boss, CEO of pen maker A.T. Cross Co.; Stanley Druckenmiller, top money manager at Soros Fund Management; and Paul Evanson, president of Florida Power & Light Co.

The cost of the November party - \$7,697 - was the charity's top money-raising expense in 1997, according to its tax return. It also spent \$7,076 on printing and mailing annual reports and a newsletter.

That means Lost Tree spends just over 2 percent of its annual take on raising money. A typical national charity spends around 15 percent to 20 percent of its money to raise money, according to the National Charities Information Bureau.

Lost Tree Village Charitable Foundation's executive director, Pamela Rue, is the only paid employee, making \$56,000 last year. Hobe Sound's charity also has a paid employee, and Abacoa's will. For all administrative expenses, including Rue's salary, the Lost Tree charity spent about 14 percent of the money it raised last year. But Rue said salaries and money-raising costs came from investment income.

Who benefits?
