

AMENDED AND RESTATED ARTICLES OF INCORPORATION

OF

LIFE-LINE, INC.

A Utah Nonprofit Corporation

Pursuant to Section 16-6a-1006 of the Utah Revised Nonprofit Corporation Act (the "Nonprofit Act"), the undersigned hereby restates (with amendments) the Articles of Incorporation of the above referenced corporation ("Corporation") to the extent and in the manner set forth herein.

FIRST: The name of the Corporation is Life-Line, Inc.

SECOND: The Articles of Incorporation of the Corporation (the "Articles of Incorporation"), are hereby amended and restated in their entirety as follows:

ARTICLE I CORPORATE NAME

The name of the Corporation is Life-Line, Inc.

ARTICLE II PURPOSES AND POWERS

The Corporation is organized exclusively for charitable, religious, educational, and/or scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under Section 501(c)(3) of the Internal Revenue Code of 1986, or the corresponding section of any future federal tax code (the "Code"). Without limiting the foregoing, the Corporation is organized to:

- (1) assist troubled youth who struggle with substance abuse, depression, family relationship problems, criminal behavior and other behavioral problems; and
- (2) support the education and training of the public, groups and individuals, especially youth, to be aware of the societal and individual risks and costs associated with substance abuse and other destructive behaviors; and
- (3) support clinical research on substance abuse, depression, family relationship problems, criminal behavior and other behavioral problems.

The Corporation shall have all powers necessary and incidental to carrying out the purposes for which the Corporation is formed.

ARTICLE III LIMITATIONS

Utah Div. of Corp. & Comm. Code

The purposes and powers set forth in Article II above shall be subject to the following limitations:

- (1) No part of the net earnings of the Corporation shall inure to the benefit of, or be distributable to, its members, directors, officers or other private persons, except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article II hereof. No substantial part of the activities of the Corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the Corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the Corporation shall not carry on any other activities not permitted to be carried on (i) by a Corporation exempt from federal income tax under Section 501(c)(3) of the Code, or (ii) by a Corporation, contributions to which are deductible under Section 170(c)(2) of the Code.
- (2) In the event the Corporation shall ever be classified as a private foundation within the meaning of Section 509(a) of the Code, then notwithstanding any other provision of these Articles of Incorporation, the Corporation shall be required to distribute its income for each taxable year of the Corporation at such time and in such manner as not to subject the Corporation to tax under Section 4942 of the Code; and the Corporation shall be prohibited from engaging in any act of self-dealing as defined in Section 4941(d) of the Code, from retaining any excess business holdings in violation of the provisions of Section 4943(c) of the Code, from making any investments in such manner as to subject the Corporation to tax under Section 4944 of the Code, and from making any taxable expenditures as defined in Section 4945(d) of the Code.

ARTICLE IV MEMBERS AND SHARES

The Corporation shall not have voting members. The Corporation may have such other class or classes of nonvoting members as the Bylaws of the Corporation may prescribe, who shall be admitted in such manner and who shall have such rights and privileges and be subject to fees, dues and assessments, if any, as provided in the Bylaws. The Corporation shall not issue or have outstanding any stock or shares.

ARTICLE V DISTRIBUTION OF ASSETS UPON DISSOLUTION

Upon the dissolution of the Corporation, assets shall be distributed for one or more exempt purposes within the meaning of Section 501(c)(3) of the Code, or shall be distributed to the federal

ARTICLE IX REGISTERED AGENT AND ADDRESS

The noncommercial registered agent of the Corporation shall be Craig Sheffield, whose address is 6 South 760 East, Kaysville, Utah 84037.

THIRD: The Corporation, by and through the undersigned, executes these Amended and Restated Articles of Incorporation and certifies that the foregoing amendments and restatement were approved by the Board of Directors of the Corporation by unanimous written consent dated effective the 21 day of January, 2016. The Corporation has no members; member action was therefore not required.
