Pasco Commission Will Meet Today

DADE CITY — The Pasco County Commission will meet in special session at 10 a.m. today at the Pasco County courthouse to wrap up its 1972-73 fiscal year.

Clerk of the Circuit Court **Miller Newton** asked last week for the special meeting so the commission can approve budget transfers and pay off as many bills as possible under its 72-73 budget.

The 1972-73 fiscal year ended Sept. 30, but state auditing procedures allow a 30-day grace period to complete as many transactions as possible.

Also up for commission consideration today is an agreement settling policies and procedures for a computerized data processing center to be shared by several county government agencies, the Pasco County School Board and the Pasco-Hernando Community College Board.

The agreement was signed Friday by **Newton**, Supervisor of Elections **Mary E. Morgan**, Tax Collector **Maxine Coulter** and Tax Assessor **Ted Williams**. It still awaits signatures from County Administrator **George Knoblock**, Sheriff **Basil Gaines** and representatives of the County Commission, School Board and college board.

Also on the commission's

agenda for today are:

- ✓ Discussion of waivers under the county's building moratorium.
- ✓ Discussion of paving of Hicks Road, Sunset Road and

Mike Road.

- ✓ Discussion of San Clemente Roads.
- ✓ Discussion of providing more space for the sheriff's office.

Thefts, Break-Ins Are Investigated

NEW PORT RICHEY — Pasco County sheriff's deputies are investigating a series of break-ins over the weekend in scattered sections of western Pasco County.

Detective Sgt. Monte Johns said deputies are investigating seven break-ins and the theft of an outboard motor.

The thefts include:

✓ A break-in reported Saturday at the home of **Joe Bolick**, 482 Perrine Ranch Road, Holiday. Thieves entered through an unlocked door and took a box of popsicles, a .32-caliber pistol and some 30-30 rifle shells valued at \$146, Johns said.

✓ A break-in at the home of **H. C. Weiss**, 887 Andy Circle, Parkwood Acres. Thieves entered through a rear door after removing a pane of glass and cutting a screen. A television set and a refrigerator were missing.

Spur service station owned by the Bear Creek In & Out store on State Road 52. Thieves forced a lock on the station's office door during the early morning hours Monday.

✓ An attempted break-in at the home of **Donald E. Howard**, 2423 1st St., Holiday Gardens Estates. The intruder apparently was scared away by the screams of Howard's daughter about 9 p.m. Friday.

✓ The theft of a television, a blender and bathroom scales from the home of **Dewey Schafer**, 230 Sunshine Park, New Port Richey. The thieves entered through a window. The items were valued at about \$150.

✓ The theft of about \$100 from a piggy bank and a glass jar at the home of **Joy Jordan**, 1221 Flamingo Lane, New Port Richey. Thieves entered the house while Mrs. Jordan was away on a trip.
