Drug rehabilitation clinic awaits zoning decision

Hopes for a local branch of a St. Petersburg drug rehabilitation program have become strained as local parents must wait for zoning clearance.

Straight, Inc. announced plans in May to open a second program Aug. 1 Sarasota was chosen as the location and officials from the rehabilitation center were on the lookout for a new home

Two locations are being eyed one on Cattleman Road near the county administration offices and another at McIntosh and Clark roads - for a facility which could eventually serve 200 or more adolescent drug abusers

But the August opening date is likely to pass and so may the revised. Sept. 1 target date as the nonprofit organization seeks the approval of the Sarasota County Planning Commission and the Sarasota County Commission.

Straight parent Ed Schwartz of Sarasota said either site will require an amendment to current zoning laws because they are zoned for industrial use. Straight's intention would be to use a warehouse building as a rehabilitation clinic.

If the zoning department and the county commissioners agree to

allow rehabilitation clinics in industrial areas. Straight would also need to apply for a special exception on its specific piece of property. According to assistant director of planning, Chuck Place, the legal process could push the official review and a public hearing on the land use into August.

Schwartz would like to shorten the waiting time by presenting
